- Have knowledge of considerations to be made in terms of the drainage and tests to carry out to determine the drainage situation on site
- Be able to select the best tools for the job and identify other equipment used in the trade



- Be able to describe the batch matching and installation process of artificial surfaces
- Have knowledge of key maintenance and aftercare information in order to prolong the life of an artificial grass surface
- Be able to look at ways of working in an environmentally sensitive way to enhance the surrounding, while minimising any harmful and negative effects on the environment.
