- Monitoring reinstatement of sub-base and base in non-bituminous materials
- Monitoring reinstatement in bituminous materials
- Monitoring reinstatement of concrete slabs
- Monitoring reinstatement of modular surfaces, concrete footways.



If successful in meeting the required standards assessed, you will be awarded the corresponding qualification (non-regulated) certificates in:



- Street Works Initial Location and avoidance of underground apparatus

- Street Works Initial Monitoring excavation in the highway
- Street Works Initial Monitoring reinstatement and compaction of backfill materials
