

## **Subject: NHSS IPV Training**

Lantra would like to announce a change in the way IPV training and assessment can be registered with Lantra.

You can now register for IPV training only, without the need for an assessment. We have created a new IPV trainee route for Learners. For specific information regarding the rules of combination, please refer to the table below for clarity.

Course/Assessment	Prerequisites	Governing Rule	End Result Options
12 TTMBC Course	None	Skill is valid for 6 months and classified as "Trainee".  If the Learner previously held a "Skilled worker" or "Supervisor" skill which expired, but no longer than 2 years, the Learner does not need to re-sit this course.	New card     Updated card     A certificate of training
12 IPV Training Course	Must hold a valid TTMBC skill or a 12ABCD certificate or card	The IPV training only skill is classified as "Trainee" valid for 2 years. If the Learner's IPV "Skilled worker" skill is within the expiry date, the IPV Training course can be used to renew the "Skilled worker" skill for an additional 5 years.	
12 IPV on Hard Shoulders Assessment	Must have completed a valid IPV training course	The skill is valid for 5 years and classified as a "Skilled worker". The date is taken from the assessment activity	<ul><li>New card</li><li>Updated card</li></ul>
12 IPV In a Live Lane on High-Speed Dual Carriageways and/or Motorways Assessment	Must have completed a valid IPV On Hard Shoulders assessment. One-day 12AB Operative Course (Minimum 3 months after TTMBC).	This assessment does not update the "on Hard Shoulder" assessment expiry date. The skill is classified as "Skilled worker". When the Live Lane assessment is combined with "on Hard Shoulders" it automatically covers the Learner for all IPV assessed modules.	
12 IPV SVW Escort Vehicle Assessment	Must hold a valid 12D M1 card or higher & the IPV course	This assessment produces an IPV SVW Escort Vehicle skill, classified as "Skilled worker". The skill is valid for 5 years.	
12 IPV Static TTM for Low-Speed Dual Carriageways Assessment	Must hold a valid 12D M3 card or higher & the IPV course	This assessment produces an IPV Static TTM for low-speed dual carriageways skill, classified as "Skilled worker". The skill is valid for 5 years.	
12 IPV Refresher Training Course	Must hold a valid IPV card	The Learner can re-sit the training course only to renew their "Skilled worker" card. The skill must be within its expiry date for the Learner to be eligible.	

- If the skill has expired, but within 6 months of the expiry date the Learner is eligible to re-sit the full training course. The grace period is only applicable for "Skilled worker" and "Supervisor" skills.
- If the Learner has let their skill expire longer than 6 months, they must reapply from the start.

• 12D M7 cannot be used as an equivalent to the TTMBC
